### ADHD Diagnosis and Treatment in Primary Care

### What's Changing?

Medsafe is allowing more doctors and nurse practitioners to be able to begin treatments with stimulant medicines for ADHD (from 1st February 2026)

- For people with ADHD 17 years and under: medical practitioners specialised in paediatrics or psychiatry and nurse practitioners working within paediatric services or CAMHS may start people on stimulant medicines
- For people with ADHD 18 years and over<sup>1</sup>: Medical practitioners specialised in paediatrics, psychiatry or general practice and nurse practitioners working within their area of practice may start people on stimulant treatments for ADHD.

### Statement from the Royal New Zealand College of General **Practitioners:**

RNZCGP states the following:

- The assessment for, and commencement where necessary, of ADHD medication, cannot happen within the standard 15-minute GP consultation.
- The college believes that appropriate assessment and formulation would take at least 1-2 hours of work
- ADHD work should not be considered part of the capitated services delivered under first contact care
- Specialist GPs will be encouraged to establish ADHD Special Interests under similar models to skin cancer work or menopause medicines, i.e., longer appointments attracting fair renumeration paid for by the patient, or government funding.

### Support for prescribers

Health New Zealand, RNZCGP and Nurse Practitioners NZ have been involved in this proposal and are in the process of scoping and developing resources, which may include training, education and guidance to support ADHD assessment, diagnosis and appropriate treatment, and practice resources to support prescribers.

RNZCGP has stated that they will establish and support Special Interest Peer Groups for specialist GPs who choose to develop ADHD as a clinical interest.

## NZ Clinical Principles Framework for Attention Deficit Hyperactivity Disorder

It is explicitly stated that this is not a clinical guideline, but a clinical framework designed for the New Zealand context. Key points:

- ADHD assessments should be comprehensive the primary diagnostic tool is an indepth clinical interview with collateral information from multiple sources
- An ADHD assessment should clearly consider differential diagnoses and alternative explanations of presenting symptoms
- The document outlines expected standards and further considerations for the agespecific assessment, diagnosis, treatment and management of ADHD within New Zealand.
